## **Swallows Parent / Teacher Consultations Autumn Term 2024**

This term's parent/teacher consultations will take place **week commencing 25 November 2024.** Meetings will take place face to face in the school hall and will be at 10-minute intervals.

Our formal reporting arrangements to parents take the form of one parent/teacher consultation in the autumn and spring terms. There will not be a parent/teacher consultation during the summer term. However, if a parent requests an appointment teachers will make themselves available.

Before each meeting, parents receive a short-written report outlining their child's current attainment, comments about personal development, targets set and SEND needs if applicable. The consultation gives parents the opportunity to discuss the report with their child's teacher.

At the end of the academic year, in the summer term, parents will receive a similar short data report, which will show a child's attainment in relation to age related expectations and attendance.

Although it has been traditional to receive an annual report in the summer term parents have said a short-written report each term is more valuable. Parents are informed early about their child's progress in relation to national expectations and can support as necessary throughout the year.
